

## Education Advisory Committee Call for Nominations

(Application Deadline for Submission: 1 December 2018)

The purpose of the Education Advisory Committee (EAC) is to identify competencies and trends to ensure the CFA Institute Programs (CFA Program, CIPM Program, and Investment Foundations) remain relevant to the finance industry.

EAC membership terms:

- must be a Regular Member of CFA Institute in good standing;
- will be appointed to a one (1) year term, renewable annually at the discretion of the Board of Governors for a maximum of six consecutive years;
- are appointed as individuals, not as representatives of their employer or other constituent groups;
- are expected to participate in two (2) in-person meetings annually (consisting of 1 1/2-day each) and on conference calls;
- may also be asked to serve from time-to-time on special purpose subcommittees.

Volunteer roles and responsibilities:

- Makes recommendations for development of practice analysis process by which the individual program Bodies of Knowledge (BOK) and competencies are developed.
- Selects BOK sections and competencies to be reviewed each year and sets priorities for the year in collaboration with the curriculum team.
- Assists in development of specialized BOK and competencies.
- Ensures that the CFA Program and other program curricula are in line with practice analysis, individual program BOK and test specifications.
- Provides guidance in the process of managing working body members.
- Collaborate with CFA Institute Strategic Divisions (Member Value and Standards and Advocacy) and leverage practice analysis process to support their strategic objectives.
- Other activities as designated by the CFA Institute Practice Analysis staff and Board of Governors.

Volunteer Experience and requirements:

Members serving as campus finance laboratory leaders with industry experience; Mainland China, India and EMEA based members; and/or professionals with primary expertise in derivatives, fixed income or Fintech; CIPM certificant a plus.

### **Application Process**

Interested applicants should submit an application and resume to the EAC Nominating Committee. The Nominating Committee will hold phone interviews with selected applicants and make their recommendations to the CFA Institute Board of Governors for approval. New members terms will start on 1 May 2019.
