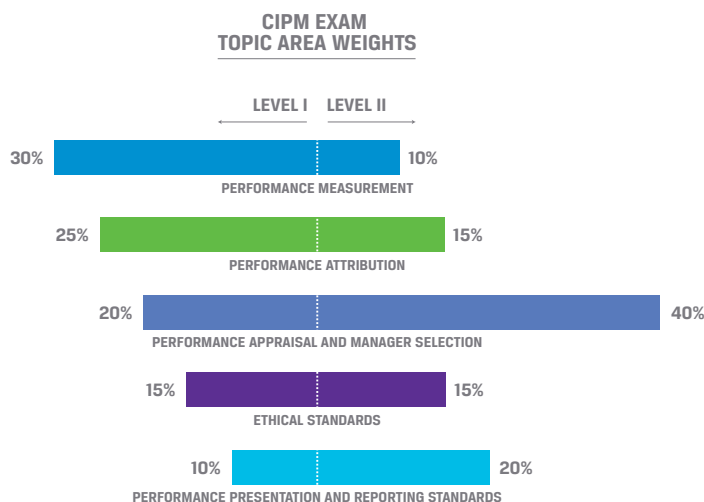


CIPM® PROGRAM LEVEL I EXEMPTION*

WHAT IS THE LEVEL I EXEMPTION OFFER?

Starting with the March 2017 CIPM (Certificate in Investment Performance Measurement) exam cycle, all CFA® charterholders and candidates who have successfully completed the CFA Level III exam are automatically granted an exemption from the CIPM Program Level I exam and are eligible to enter and complete the CIPM Program directly at Level II.

This change is significant because to date, all candidates have needed to complete and pass two exam levels (Principles and Expert), in addition to fulfilling the professional conduct and experience requirements, to be eligible for the CIPM designation.



WHY ARE WE OFFERING THIS EXEMPTION?

The Level I exam exemption is an acknowledgement that CFA charterholders, and those who have successfully passed the CFA Program Level III exam, have already mastered the curriculum and key learnings covered in this course of study.

ARE THERE ANY RESTRICTIONS TO THIS OFFER?

The offer applies to CFA charterholders and to candidates who have successfully completed the CFA Program Level III exam unless they are restricted because of conduct violation. Professional conduct and experience requirements still apply. Eligible candidates may sit for CIPM Level II beginning with the March 2017 CIPM exam.
